### What does the fund invest in?

The Fund invests only in unencumbered, fully allocated silver bullion. It has a fixed investment policy that requires it to purchase silver bullion regardless of market conditions.

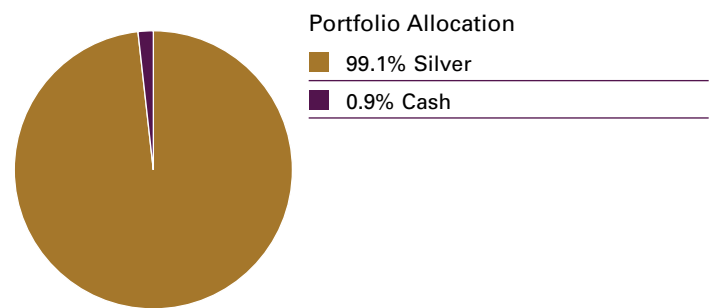
The charts below give you a snapshot of the Fund's investments on October 31, 2019. The Fund's investments will change.

### How risky is it?

The value of the Fund can go down as well as up. You could lose money.

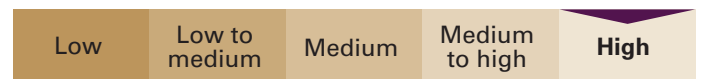
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

BMG Management Services Inc. has rated the volatility of this Fund as **high**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

### No guarantees

Like most mutual funds, this Fund does not have any guarantees. You may not get back the money you invest.

**How has the Fund performed?**

This section tells you how the Class D units of the Fund have performed since inception. Returns are after fund expenses have been deducted. These expenses reduce the Class D units’ returns.

**Year-by-year returns**

Since the Class has been distributing securities under a simplified prospectus for less than one calendar year, the information is not available.

**Best and worst 3-month returns**

Since the Class has been distributing securities under a simplified prospectus for less than one calendar year, the information is not available.

**Average return**

The annual compound return of Class D units of the Fund was 3.5% since inception. If you had invested \$1,000 in the Fund since inception, your investment would be worth \$1,063 as of October 31, 2019.

**Who is this fund for?**

Investors who want:

- Investments in a silver bullion only fund
- Capital preservation and long term appreciation in silver
- Portfolio diversification and hedging against the volatility of other investments. This Fund is not intended to be a stand-alone investment, and should not represent more than 20% of an investor’s overall total investment portfolio including any other bullion investments. Due to the fact that silver bullion typically has a low correlation to other financial assets, including it as part of an investment portfolio should generally reduce the portfolio’s volatility (i.e., which may help improve returns over the long-term).

**ⓘ Do not invest in this Fund if you need a steady source of income from your investments.**

**A word about tax**

In general, you’ll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell Class D units of the Fund. The fees and expenses – including any commissions – can vary among classes of the Fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**

No sales charges apply when you buy or sell Class D units of the Fund. Instead you pay a fee directly to your discount dealer.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of June 30, 2019, the Fund's expenses were 2.50% of its value. This equals \$25.00 for every \$1,000 invested.

**More about the trailing commission**

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for services that your discount dealer provides to you.

BMG Management Services Inc. pays the trailing commission to your discount dealer. It is paid from the Fund's management fee and is based on the value of your investment. Your discount dealer may receive an annual trailing commission of up to 0.25% of the value of your investment each year. This equals up to \$2.50 each year for every \$1,000 invested.

**3. Other fees**

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

<b>Fee</b>	<b>What you pay</b>
<b>Short-term trading fee</b>	Up to 1.5% if a redemption occurs within 60 days of purchase or switch.
<b>Switch fee</b>	None. Your representative may charge you up to 2% of the net asset value of any units of a class of a fund that you switch to the corresponding class of another fund for this service.
<b>Redemption fee</b>	None. Your representative may charge you a fee for this service.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
