**What does the fund invest in?**

The Fund invests only in unencumbered, fully allocated gold, silver and platinum bullion. It has a fixed investment policy that requires it to purchase equal dollar amounts of gold, silver and platinum bullion regardless of market conditions.

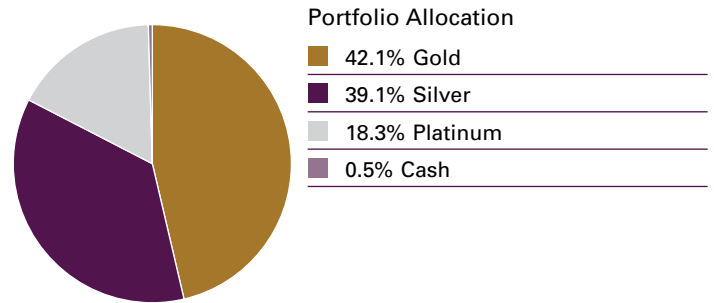
The charts below give you a snapshot of the Fund’s investments on Oct 31, 2024. The Fund’s investments will change.

**How risky is it?**

The value of the Fund can go down as well as up. You could lose money.

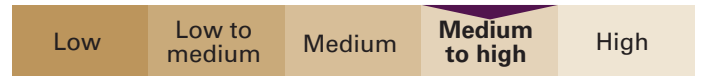
One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

**Risk rating**

BMG Management Services Inc. has rated the volatility of this Fund as **medium to high**.

This rating is based on how much the fund’s returns have changed from year to year. It doesn’t tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

**No guarantees**

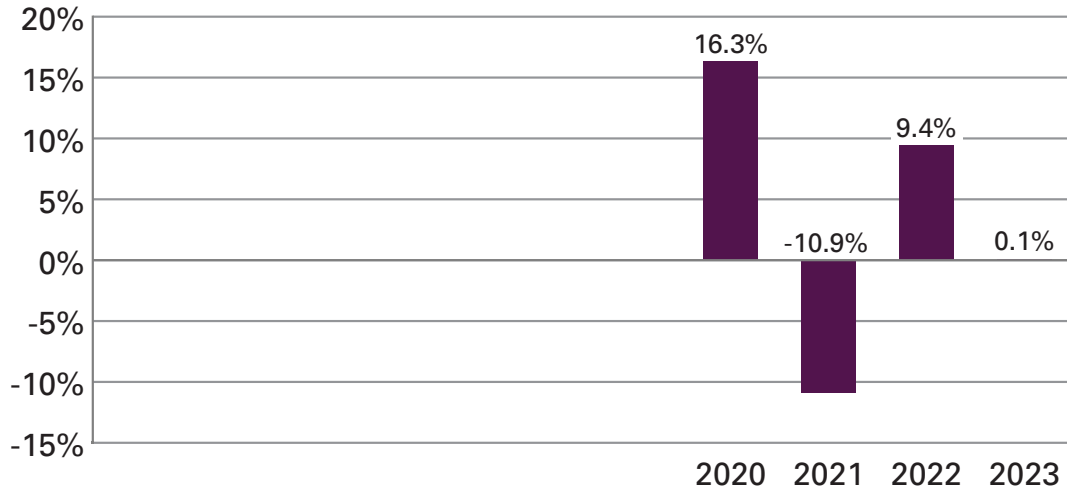
Like most mutual funds, this Fund does not have any guarantees. You may not get back the money you invest.

**How has the Fund performed?**

This section tells you how the Class C3 units of the Fund have performed since inception. Returns are after fund expenses have been deducted. These expenses reduce the Class C3 units’ returns.

**Year-by-year returns**

This chart shows how the Class C3 units of the Fund have performed for the past 4 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



**Best and worst 3-month returns**

This table shows the best and worst returns for Class C3 units of the Fund in a 3-month period over the past 4 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

**Average return**

The annual compound return of Class C3 units of the Fund was 9.2% since inception. If you had invested \$1,000 in the Fund since inception, your investment would be worth \$1,422 as of Oct 31, 2024.

**Who is this fund for?**

Investors who want:

- Investments in a precious metals bullion only fund
- Capital preservation and long term appreciation in precious metals
- Portfolio diversification and hedging against the volatility of other investments. This Fund is not intended to be a stand-alone investment, and should not represent more than 20% of an investor’s overall total investment portfolio including any other bullion investments. Due to the fact that bullion typically has a low correlation to other financial assets, including it as part of an investment portfolio should generally reduce the portfolio’s volatility (i.e., which may help improve returns over the long-term).

**⚠ Do not invest in this Fund if you need a steady source of income from your investments.**

**A word about tax**

In general, you’ll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell Class C3 units of the Fund. The fees and expenses – including any commissions – can vary among classes of the Fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**

This class is only available to investors who have a fee-based or other account with their representative and whose representative has signed an agreement with us. There are no sales charges, trailing commissions or other fees payable to your representative for this class. However, you pay a fee to your representative for investment advice and other services.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of June 30, 2024, the Fund's expenses were 1.62% of its value. This equals \$16.20 for every \$1,000 invested.

**More about the trailing commission**

There is no trailing commission for Class C3 units.

**3. Other fees**

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

<b>Fee</b>	<b>What you pay</b>
<b>Investment advisory fee</b>	This class of units is only available to investors who have a fee-based account with their representative and whose representative has signed an agreement with BMG Management Services Inc. You pay a fee to your representative for investment advice and other services.
<b>Short-term trading fee</b>	Up to 1.5% if a redemption occurs within 60 days of purchase or switch.
<b>Switch fee</b>	None. Your representative may charge you up to 2% of the net asset value of any units of a class of a fund that you switch to the corresponding class of another fund for this service.
<b>Redemption fee</b>	None.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
